SPECIFIC INFORMATION

Each player is to supply their own personal playing gear ie. boots, headgear, mouthguards, water bottles, hat, sunscreen etc. As per CARA Guideline for rugby union, mouthquards must be worn in order to participate. All students will be required to complete the Mouthguard Form (contained within the Permissions Booklet) prior to trialling. Boots must be worn. Headgear is encouraged. NO AGE DISPENSATION IS ALLOWED FOR THIS TRIAL

For this trial the students nominate 2 preferred playing positions. This will need to be indicated in the excel nominations spreadsheet.
