

Absent competitor application form

Information for applicants

This form outlines eligibility criteria for students seeking alternate selection consideration for advancement to the next level of competition in the Queensland Representative School Sport program. Eligibility is granted to students who are unable to participate in trials due to circumstances such as illness, injury, authorised school events, or events beyond their control. These circumstances must not be a result of the student's deliberate choice or that of their parents/caregivers (e.g. family holidays).

The purpose of this form is to enable a parent/carer/independent student athlete to advise their team official of an absence, and request consideration for selection, by providing the reason they are unable to compete.

Please note: Submission *of the Absent competitor application form* serves as a request for alternate selection consideration and does not guarantee automatic placement in the team.

Instructions

To be considered for an exemption, the applicant is to:

• complete **Sections A to F** of this Absent competitor application form and return the entire form (including blank **Section G**) and any accompanying documents to the responsible officer (below) prior to the commencement of the event;

or

• in the case of **injury or illness on the day of the event**, complete **Sections A to F** of this Absent competitor application form and return the entire form (including blank **Section G**) prior to the start of competition, and any supporting documentation must to be provided within 24 hours of the competition commencement.
