Terms & Conditions of Use



IMPORTANT NOTICE ABOUT USE OF THE MACKAY CHRISTIAN COLLEGE (M.A.D) DIRT BICYCLE TRACK

All persons who wish to use the MCC MAD MTB Skills Park track (referred to in this notice as the **facility**) must read this notice and be aware that its use is subject to the terms and conditions set out below. You are not permitted to use the facility unless you accept that your use is subject to those terms and conditions.

The MCC MAD MTB Skills Park (the **facility**) has been provided by Mackay Christian College in partnership with MADMTBC (Mackay and District Mountain Bike Club) solely for off road bicycles. There is a risk of injury, including catastrophic and fatal injury, associated with the use of the facility. Injury may be caused in many ways including, for example, a collision with other users or people present or falling from a bicycle. All persons using the facility or present at it are warned that there is a risk of injury, including fatal and catastrophic injury.

Terms & Conditions

- 1) All users must either be:
 - a. A student at the College
 - b. Employed by the College
 - c. A current member of Mountain Bike Australia through MADMTBC or another club.

- 2) Use of the facility is at the risk of the user and on the condition that to the extent permitted by law the College disclaims all liability for injury, loss or damage to users and other persons present at any time.

- 3) The following activities may increase the risk of injury and are prohibited:
 1. Use of the facility by persons using other than off road bicycles.
 2. Use of the facility by persons not wearing a safety helmet and appropriate protective gear.
 3. Attempting jumps which are outside the skill level of the user.
 4. Riding in any direction other than clockwise.
 5. Endangering other users or persons present by riding in an aggressive manner or without regard to the risk to others.
 6. Riding in a reckless fashion.
 7. Use of the facility during wet weather, when the ground or surface of the facility is soft or slippery or if any part of the facility is damaged.
 8. Use of the facility when there are cars, motorcycles, dogs or glass objects (such as bottles) present or nearby.
 9. Use of the facility while under the influence of alcohol or drugs or having consumed alcohol or drugs in the 48 hours prior to using the facility.
 10. Use of the facility after homemade or professionally constructed obstacles, ramps, jumps have been introduced or other modifications made to it.
 11. Introducing homemade or other obstacles, ramps jumps or modifications to the facility.

- 4) The facility is not supervised.

- 5) The facility is not open to the public during school hours or while pre-arranged events are taking place.

- 6) Smoking at or near the facility or on school property is prohibited.

- 6) Access to the Facility is from Quarry Street only, via the underside of the Trade Training Centre. Access to all other College Buildings and pathways is prohibited.

- 7) This is your facility. Please help us to keep it in good condition by reporting any damage or misuse to the Mackay Christian College Office.
